In terms of size and prestige, among the numerous events the Formula 1 World Championship Grand Prix and the Superbike World Championship stand out. The racetrack represents a milestone in the motor sport history of the Motor Valley and it extends for about 5 km inside the Park of Acque Minerali, the historical green lung of the Municipality of Imola.

Formula Imola S.p.A., through the achievement of the FIA Environmental Accreditation - 1 Star for the International Circuit Enzo and Dino Ferrari, has already shown considerable sensitivity towards reducing the environmental impact in the management of the location.

Furthermore, the direct involvement of the local administration, in the role of the Department of the Circuit, tourism and services to the citizens, is a symbol of the attention paid to the social and economic impact that the International Circuit Enzo and Dino Ferrari generates locally.

The decision to adopt an integrated system for the sustainable management of events, through the achievement of ISO 20121 and 14001 certifications, represents a further significant step in the path of environmental, social and economic sustainability undertaken by Formula Imola S.p.A.
